Order

Sri GK. Sampath Kumar has filed complaint dated **23-10-2020** which was received by this Commission on **23-10-2020** for not getting the information sought by him from the Public Information Officer/ The DGM (Per), O/o the SCCL., Kothagudem Area, Bhadradi – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **13-08-2020** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- ① Please arrange to supply copy of circulars and approved note copy of CRP/PER/PM/4/EP/151 dt 25.1.2008.
 - ② Please arrange to supply copy of circulars and approved note copy commented to circulars CRP/PER/PM/2229/2060 dt 22.9.2008
 - ③ Please supply copy of circulars no CRP/PER/PM/2229/446 dt 17.02.2011 and approved note copy of the circulars.
 - ④ Please supply a copy of circulars no CRP/PER/PM/2229/2379 dt 13.6.2015 and approved note copy of the circulars.

The Public Information Officer through Letter dated 02-09-2020 furnished available information to the complainant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of “Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is absent. The PIO/Sri Dhanpal Srinivas, DGM(P), SCCL, Kothagudem Area is present and submitted that vide letter Ref.No.CRP/RTI-PIO/3124/693, dated.09-09-2020 the information sought by the appellant was furnished through registered post. The PIO further submitted a copy of the information along with the copy of the postal acknowledgement.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
