Order

Sri G.K. Sampath Kumar has filed second appeal dated **23-10-2020** which was received by this Commission on **23-10-2020** for not getting the information sought by him from the Public Information Officer/ The DGM (Per), O/o the SCCL., Kothagudem Area, Bhadradi – Kothagudem District and the First Appellate Authority/ The GM (HRD), SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **04-07-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Under RTI Act 2005.
- ① Please arrange furnish the Dependent employment Committee constituted for Corporate for the years 2018 April to till date designatowise.
 - ② Please furnish the number of Dependents were interviewed from April' 2018 to May' 2020. as per the seniority or as per the influence of unions/ individuals.
 - ③ Please furnish Sri A. Manoj Kumar to Sri A. Prakash Rao son was interviewed as per the seniority or as per my request/ influence.
 - ④ please furnish the procedure being followed by Corporate Dependent employment Committee to interview dependant.

The GM (Per) through Letter dated 25-07-2020 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **10-08-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 17-08-2020 requested the Public Information Officer to provide the sought/ available information to the applicant.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of "Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is absent. The PIO/Sri Dhanpal Srinivas, DGM(P), SCCL, Kothagudem Area is present and submitted that vide letter Ref.No.CRP/RTI-PIO/3082/532, dated.28-07-2020 the information sought by the appellant was furnished through registered post. The PIO further submitted a copy of the information along with the copy of the postal receipt.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
