## Order

Sri G.K. Sampath Kumar has filed second appeal dated **23-10-2020** which was received by this Commission on **23-10-2020** for not getting the information sought by him from the Public Information Officer/ The DGM (Per), O/o the SCCL., Kothagudem Area, Bhadradri – Kothagudem District and the First Appellate Authority/ The GM (HRD), SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **18-08-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- Please furnish --
- the cheques on specific dates though the cheques -- issued earlier by Sri N. Sridhar, DAS, RA, MD in connection with the payments made against Guest house charges for using the accommodations furnished in WP:1929/2020 Affidavit for seeking quashing the FIR 44/2020.
- ① Cheque No: 047788, dt: 15.1.2017 was remitted on 4.2.2017 reasons for remitting on 4.2.2017. also furnish SCL Bank Account Number (Public sector) and the A/c Number of the cheque.
  - ② Cheque No: 047790, dt: 3.4.2017 remitted on 7.4.2017, reason for remitting on 7.4.2017 also furnish SCL Account Bank number and the Account number of the cheque.
  - ③ Cheque No: 047793, dt: 12.6.2017 remitted in SCL Account on 14.6.2017. Furnish the reasons for remitting on 14.6.2017. Please furnish SCL Bank Account number and the Account number of the cheque.
  - ④ Cheque No: 000023, dt: 11.7.2017 remitted to SCL Bank Account on 13.7.2017, reasons for remitting on 13.7.2017, and arrange to furnish the Account number of the said cheque and Srigalemi Collieries Bank Account number as the above said transactions take place in a (Public sector) from seeking the said information as the information number and the

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **19-09-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 28-09-2020 requested the Public Information Officer to provide the sought/ available information to the applicant.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of "Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Cases were heard on 11-01-2022. The appellant is absent. The PIO/Sri Dhanpal Srinivas, DGM(P), SCCL, Kothagudem Area is present and submitted that vide letter Ref.No.CRP/RTI-PIO/3128/747, dated.18-09-2020 the appellant was informed that the since the information sought by him will fall under exemption of disclosure under Section 8(1)(e), 8(1)(h) & 8(1)(j) of RTI Act, 2005, hence the same was rejected.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has rejected to furnished the information to the appellant as per Section 8(1)(e), (h) & (j) of RTI Act, 2005.

In view of the above, the appeal is closed.
