Order

Sri M. Ramchander has filed complaint dated **26-07-2021** which was received by this Commission on **30-07-2021** for not getting the information sought by him from the Public Information Officer/ The Assistant Director, O/o the Mines & Geology, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **16-04-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **04-01-2022 at 10.30 AM.**

The Cases were heard on 04-01-2022. The complainant is absent. The PIO/ Sri B.Satyanarayana, Assistant Director, Mines & Geology, Karimnagar District is present and stated that vide letter Lr.No.3441/E/2005, dated.04-05-2021 the information sought was furnished in their office personally to the complainant. The PIO further submitted a copy of the information along with the copy of the personal endorsement of the complainant.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaints are closed.
