## Order

Sri K. Kalappa has filed second appeal dated **04-08-2021** which was received by this Commission on **04-08-2021** for not getting the information sought by him from the Public Information Officer/ O/o the DM&HO., Vikarabad District and the First Appellate Authority/ O/o the DM&HO., Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **30-03-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) పాలిషిల ద్వారా వచ్చి పేసెంట్లకు ట్రీట్ మెంట్ చేసిన, ఎక్సరెల తీసిన వివరాలు పోస్ట్మెంట్కు సమంధానంగా రికార్డులలో M.L.C రిజిస్ట్రేషన్ లో లాయకులూ, ఎలక్ట్రీ సిస్టమ్ సర్టిఫికేషన్ వచ్చినట్లుంటే పాలిషిల ద్వారా వచ్చిన పేసెంట్లకు ట్రీట్ మెంట్ వివరాలు మరియు x-ray వివరాలు ప్రాసెస్ చేయవలసివుంటే అధికారికంగా చెబుతూనా, చెబుతూ ఉన్నా యొకం తెలుగుగలవ. (డౌక్టర్ IP సౌకర్య ప్రాసెస్ చేయటం)
- 2) యీ అప్యాలయికి సంబంధించి R.T.I act 2005 U/sec 4 (1) (b) ప్రకారం 17 యంశాలు సంబంధించి సమాచార పత్రాలు ఇవ్వవలసివుంటుంది.

The Public Information Officer through Letter dated 07-04-2021 requested the CHC., Vikarabad, CHC Pargi, CHC Kodangal & District Hospital, Tandur to furnish information to the applicant directly under intimation to their office.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **18-06-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-03-2022 at 10.30 AM.**

The Case is heard on 22-03-2022. The appellant is absent. Dr.Raju, Civil Assistant Surgeon on behalf of the PIO/Administrative Officer, O/o the DM & HO, Vikarabad District is present and through affidavit requested the Commission to provide them two weeks of time to furnish the information to the appellant.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against Public Information Officer for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the appellant within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
