Order

Sri V. Gnaneswar has filed second appeal which was received by this Commission on **05-08-2021** for not getting the information sought by him from the Public Information Officer/ O/o the District Educational Officer, Jagtial District and the First Appellate Authority/ the District Educational Officer, Jagtial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **20-10-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Please provide the Certified copy of salary bill with names of staff members , received from kgbv Ibrahimpatnam for the months of May and June-2019, Audited by Competent authority, at DEO Office Jagtial
- 2) Why the PGCRT English post in KGBV Ibrahimpatnam school which was vacant from 09-05-2019 was not send for temporary recruitment for English PGCRT posts which was conducted in September 2019
- 3). Please provide the time table with teachers names, of kgbv ibrahimpatnam intermediate 1st year and 2nd year classes as per which classes were conducted to intermediate 1 St year and 2 nd year students in 2019 September and October months
- 4) Please provide the official phone number of public information officer and first appellate authority
- 5) Please provide the Certified copy of salary bill with names of staff members Who worked on temporary basis, and Audited by Competent authority, at DEO Office Jagtial and Received From

5A) KGBV Korutla for the months of August-2019

5B) KGBV Jagtial for the months of August-2019

6) please provide consolidated list of English PGCRT candidates, who recruited through contract agreement, who worked and presently working in KGBV Schools in jagtial district from june- 2018 to till date in the tabular format given below

8). Please Provide the copy of citizen's charter implementing in DEO, Jagtial Office Regarding SA) Complaint Received through inward

The Public Information Officer through Letter dated 03-11-2020 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **12-01-2021** before the First Appellate Authority/O/o the District Collector, Siddipet District requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Letter dated 20-01-2021 informed to the appellant that the sought information is not available in their office. It is available with Special Officer, KGBV., Ibrahimpathnam.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-02-2022 at 10.30 AM.**

The Case is heard on 22-02-2022. The appellant is absent. The PIO/Sri A.ShivaKrishna, Assistant Director, O/o the District Educational Officer, Jagtial District is present and stated that vide letter No.103/A6/RTI/2020, dated. 03-11-2020 the available information was furnished to the appellant through registered post. The PIO further filed a copy of the information along with the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
