Order

Sri B. Krishna has filed complaint dated **28-07-2021** which was received by this Commission on **09-08-2021** for not getting the information sought by him from the Public Information Officer/ The District Educational Officer, Siddipet District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **21-06-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Letter dated 03-07-2021 & 06-07-2021 requested the B2 Section in their office to submit the information immediately so as to enable him to send the same to the applicant.

Stating that the complainant did not get any response from the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-02-2022 at 10.30 AM.**

The Case is heard on 22-02-2022. The complainant is present and stated the PIO has furnished the information. The PIO/Sri L.Venkateshwar Reddy, Assistant Director, O/o the District Educational Officer, Siddipet District is present and stated that vide letter Lr.No.1719/B1/RTI/2021, dated.10-08-2021 the information sought by complainant was furnished through registered post. The PIO also filed a copy of the information along with the copy of the postal receipt as a proof of dispatch.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
