Order

Sri Syed Khasimhussain has filed second appeal dated **16-11-2020** which was received by this Commission on **20-11-2020** for not getting the information sought by him from the Public Information Officer/ The Dy. GM (PER), SCCL., Kothagudem Area, Bhadradi – Kothagudem District and the First Appellate Authority/ The GM (HRD), SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **06-09-2020** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Information Act, 2005. The information sought by the appellant is not furnished.

- 1) Order No.7600007664 Dated:30.01.2019 issued for the work of drilling, excavation, transportation, loading, dumping etc., at JVR OC-II of over burden **with hired HEMM in combination with not more than 8 nos of conventional equipment at JVR OC-II,Project SCCL Kothagudem area** was issued to M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 by GM(CM) SCCL Kothagudem. The proofs of compliance of section – 52 of mines Act,1952 by M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 for the period from 01.02.2019 to 31.08.2020 may please be provided.
- 2) The proofs of compliance of clause-1.1.3(a),(b)(c)&(d), 1.1.4(b),1.6(i),(k), 1.8(b)(i)(ii),1.8(d)(ii),1.9(c) of work Order No.7600007664 Dated:30.01.2019 by M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 for the period from 01.07.2020 to 31.08.2020 for the work of drilling, excavation, transportation, loading, dumping etc., at JVR OC-II,Project SCCL Kothagudem area along with documentary evidences may please be provided.
- 3) The total numbers of skilled, semi skilled, un skilled,clerical and administrative staff/workers **with their names** engaged by M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 for the work of drilling, excavation, transportation, loading, dumping etc., at JVR OC-II,Project SCCL Kothagudem area as on 01.09.2020 may please be provided.
- 4) Xerox copy of Form-H under rule 53 of mines rules 1955 maintained by M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 for the work of drilling, excavation, transportation, loading, dumping etc., at JVR OC-II,Project SCCL Kothagudem area from the period from 01.02.2019 to 31.08.2020 may please be provided.
- 5) Xerox copy of Form-F under rule 49(4) of mines rules 1955 maintained by M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 for the work of drilling, excavation, transportation, loading, dumping etc., at JVR OC-II,Project SCCL Kothagudem area from the period from 01.02.2019 to 31.08.2020 may please be provided.
- 6) Xerox copy of Form-G under rule 53 of mines rules 1955 maintained by M/s Sushee Hitech Projects Pvt Ltd, Hyderabad-34 for the work of drilling, excavation, transportation, loading, dumping etc., at JVR OC-II,Project SCCL Kothagudem area from the period from 01.02.2019 to 31.08.2020 may please be provided.

More (5) points.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **12-10-2020** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The Public Information Officer through Letter dated 02-11-2020 requested the PO, JVROCP (Deemed PIO), Kothagudem Area to furnish the information as required by the applicant, at the earliest on or before 10-08-2020 under intimation to their office.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **21-12-2021 at 10.30 AM.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/G.C./1170 dated 14-12-2021 submitted that he was engaged in preparation work of "Singareni Formation Day Celebrations to be celebrated on 23-12-2021 and hence requested the Commission to postpone the hearing date.

In view of the above, informed to both the parties over phone to attend for hearing on **11-01-2022 at 10.30 AM.**

The Case is heard on 11-01-2022. The appellant is present and through affidavit stated that he has received the information on the day of hearing. The PIO/ Sri P.Sammuel Sudhakar, Dy.General Manager(Personnel), O/o the SCCL, Kothagudem Area is present and stated that vide letter Ref No.KGM/IED/RTI/218/3515, 23-12-2020 part information was furnished to the appellant through registered post. The PIO further submitted a copy of the letter along with the copy of the acknowledgement.

Heard both the parties and perused the material papers available on record. The Commission observed that the appellant through affidavit stated that he has received the information.

Since the information is furnished, the appeal is closed.
