## **Order**

Sri I. Narsaiah has filed complaint dated **11-08-2021** which was received by this Commission on **13-08-2021** for not getting the information sought by him from the Public Information Officer/ The Assistant Director, O/o the Mines & Geology, Mancherial District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **27-03-2021** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Letter dated 23-04-2021 furnished available information to the complainant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notices are issued to both the parties to attend for hearing on **04-01-2022 at 10.30 AM.**

The Case was heard on 04-01-2022. The complainant is absent. The PIO/ Sri R.Balu, Assistant Director, Mines & Geology, mancherial District is present and stated that vide letter Lr.No.526/RTI/2021, dated.23-04-2021 the available information sought by the complainant was furnished through registered post. The PIO further submitted a copy of the information along with the copy of the postal receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
