Order

Sri S. Ramchander, Komarambheem Asifabad District has filed a Complaint dated 23-11-2020 which was received by this Commission on 25-11-2020 for not getting the information sought by him from the PIO / District Revenue Officer, O/o the District Collector, Mancherial District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 12-10-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. నా యొక్క ఫిర్యాదు/ ప్రాధానిత్యం మీ వద్దకు వచ్చిన నాటి నుండి ఇప్పటివరకు ఏకాభిప్రాయం ఆధికారి వద్దకు పంపించినారో తెలుపగలరు. ఇంకా ఆ ఆధికారి వద్ద వుంది? ఇప్పటి వరకు అయిన చట్టబద్ధ చర్యలను ఇవ్వగలరు.
2. నా యొక్క ఫిర్యాదు/ ప్రాధానిత్యం సంబంధించిన అధికారుల వద్దకు పంపించినట్లయితే వాటికి సంబంధించి మీ కార్యాలయంలో వున్నా రుజువులు అందించగలరు.
3. మీ కార్యాలయ నియమావళి లేదా పారసీవా పత్రాన్ని అనుసరించి ఎన్ని రోజులలోగా పరిష్కరించాలి. ప్రవర్తనా నియమావళిని అనుసరించి ఆ విషయంలో సమయ పాలన మీ కార్యాలయ ఉద్యోగుల ప్రవర్తనా నియమావళిని అనుసరించి వారిపై తీసుకోవలసిన చర్యల వివరాలు తెలుపగలరు. చర్యలు తీసుకోకపోవడానికి గల కారణాలను తెలుపగలరు. ఎంత వ్యవధిలోగా పరిష్కరించాలనే తెలుపగలరు. మరియు దాని ప్రస్తుత స్థితిని తెలుపగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 17-09-2021 at 12:00 P.M.

The case is called on 17-09-2021. The complainant is present and stated that the PIO has not furnished the information. The APIO / Sri K. Suresh, Administrative Officer is present on behalf of the PIO / Sri Madhusudhan Naik, Additional Collector / District Revenue Officer, Mancherial District and stating that vide letter Rc. No: B2/202/2021 dated: 30-03-2021 the application forwarded to the Municipal Commissioner, Luxettipet Municipality, Mancherial District with a request to enquire into the contents and take suitable action as per rules. The PIO filed a copy of the letter before the Commission.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 12-10-2020 seeking the action taken on his complaint dated: 17-09-2020 & 29-09-2020 and the PIO has forwarded the application on 30-03-2021 to the Municipal Commissioner, Luxettipet Municipality, Mancherial District. The PIO ought to have informed the same to the complainant.

The Commission directs the PIO – I / District Revenue Officer, Mancherial District to inform the factual position to the complainant within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and also directs the PIO – II / O/o the Municipal Commissioner, Luxettipet Municipality, Mancherial District to furnish the action taken on the complaint dated: 17-09-2020 & 29-09-2020 which was forwarded by the District Revenue Officer, Mancherial District vide letter Rc. No: B2/202/2021 dated: 30-03-2021 to the complainant within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
