Order

Sri. M. Lingam, Kamareddy District has filed 2nd appeal dated: 24-11-2020 which was received by this Commission on 27-11-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Ramareddy Mandal, Kamareddy District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Kamareddy Division, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 21-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) ముద్దికొండపల్లి రెవెన్యూ పంచాయతీ నుండి వివరాలు పొందజేయమని వాటిని కోరుతున్నాను. వాటిని పంపించమని కోరుతున్నాను.
- 2) గతంలో నుండి వివరాలు పొందజేయమని కోరినా అయితే పంపించలేదు. వాటిని పంపించమని కోరుతున్నాను.
- 3) ముద్దికొండపల్లి రెవెన్యూ పంచాయతీ నుండి 2020-08-21 తేదీన 3.15 ఏ.ఎం. కు కోరినా. ఎవరైనా మీదికి వచ్చి సమాధానం ఇవ్వమని కోరుతున్నాను. వాటిని పంపించమని కోరుతున్నాను.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 14-10-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 06-08-2021 at 10.30 A.M.

The case is called on 06-08-2021. The appellant is present and filed his affidavit stating that the PIO has furnished incomplete information. The APIO / Ms. K. Lalitha, Senior Assistant, O/o the Tahsildar, Ramareddy Mandal, Kamareddy District is present and filed affidavit stating that the information was furnished to the appellant vide letter No: B/345/2020 dated: 05-12-2020 and filed the copy of the information furnished before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant through his 6(1) application dated: 21-08-2020 seeking information on 4 points and the PIO has furnished incomplete information.

The Commission directs the PIO to furnish the balance and complete information once again to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
