

Order

Sri Putturu Peda Venkata Reddy, Suryapet District has filed a Complaint dated: 22-06-2018 which was received by this Commission on 06-07-2018 for not getting the information sought by him from the PIO / O/o the IInd Additional Junior Civil Judge's Court, Miryalguda, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 04-04-2018 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 17-09-2021 at 10.30 A.M.

The case is called on 17-09-2021. The complainant is present and stated that the PIO has not furnished the information. The PIO / Superintendent, O/o the IInd Additional First Class Magistrate Court, Miryalguda, Nalgonda District is absent.

Perused the material papers available on record and observed that the complainant filed 6(1) application dated: 04-04-2018 seeking certain information and the PIO vide letter Dis. No: 117/2018 dated: 09-04-2018 informed the complainant that the APIO has no control over the Court proceedings and the case records cannot be furnished.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO / Superintendent, O/o the IInd Additional First Class Magistrate Court, Miryalguda, Nalgonda District for not appearing before the Commission for the hearing held on 17-09-2021. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the complaint is closed.
