Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed 2nd appeal dated: 18-01-2020 which was received by this Commission on 24-01-2020 for not getting the information sought by him from the PIO / O/o the District Educational Officer, Nalgonda District and 1st Appellate Authority / O/o the Regional Joint Director for School Education, Aliya Junior College Premisses, Gunfoundry, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 25-12-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. TEACHER TRANSFERS 2018 లో SPOUSE CATEGORY POINTS ను వాడిన ఉపాధ్యాయుల transfer order జాబితాను జిల్లా మరియు మండలం వారిగా, subject వారిగా ఇవ్వగలరు. వారు సమర్పించిన spouse certificate ను ఇవ్వగలరు. వీరి SPOUSE ఏ మండలంలో విధలు నిర్వహిస్తున్నారు వారి మండలం పేరు ను తెలపగలరు

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 02-01-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri J. Rama Chary, Assistant Director, O/o the District Educational Officer, Nalgonda District is present and filed his affidavit stating that a reply was given to the appellant vide letter No: 994/B5/2020 dated: 07-02-2020 informing that the transfer Counseling was held online by the Regional Joint Director of School Education, Hyderabad and the Spouse Certificate were issued by the concerned Mandal Educational Officers and the required information is not available in their office. The PIO further requested to file application before the concerned MEO's to seek the information directly. The PIO filed copy of the letter before the Commission.

Sri V.A.V. Prasad, Senior Assistant is present on behalf of the PIO / Sri A. Saipurna Chander Rao, Assistant Director, O/o the Regional Joint Director of School Education, Hyderabad stating that vide letter No: 5027/RTI/A3/2019 dated: 20-01-2020 the application was transferred u/s 6(3) of the RTI Act 2005 to all the DEO's in the State with a request to furnish the information to the appellant and vide letter Rc. No: 1410/A3/RTI/2021 dated: 16-06-2021 and 20-07-2021 the appellant was informed that the information sought is not specific and pertains to O/o the Director of School Education, Hyderabad and filed a copy of the same before the Commission.

Heard the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 25-12-2019 seeking information the list of transfer of the Teachers in Spouse Category during the year 2018 District, Mandal and Subject wise. The PIO furnished the copy of the list available before the Commission. The appellant stated that the information furnished is incomplete.

The Commission directs the PIO to give a specific reply and furnish the balance information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
