## Order

Sri K. Srinivas, Kamareddy District has filed 2<sup>nd</sup> appeal dated: Nil which was received by this Commission on 05-12-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District and 1<sup>st</sup> Appellate Authority / O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 23-09-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. మీ కార్యలయం పరిధిలో గల సర్వే నం: 800/బులు అహోకేనగర్ - లో తాళ్ళపల్లి షోరూమ్ ప్రాంతానికి గల ప్లాటుల కట్టిన ఇల్లు ఎవరి పేరు మీద పరిమిషన్ ఇచ్చారు, 'ఇల్లు' కట్టడానికి ఎన్ని గజలకు అనుమతి ఇచ్చారు పొడవు ఎంత వెడల్పు. ఎన్ని ఫీట్లు, ఎన్ని ఫీట్లు సెట్ బ్యాక్ ఎన్ని ఫీట్లు అనుమతి ఇచ్చారు. కాల. నర్సవ్వయ్య గంగయ్య ప్లాట్ నం: 125, తాళ్ళపల్లి షోరూమ్ ప్రాంతానికి వల్లట్ల రుద్రాచారి ఎన్ని ఫీట్లు రోడ్డు ఉండే ఇల్లు ఎన్ని ఫీట్లు రోడ్డు ఉంటుంది. మీరు కొలచి 'సర్టిఫై చేసిన కాపీ నకలు, ఫింటి మ్యాప్ నకలు, తాళ్ళపల్లి షోరూమ్ ప్రాంతానికి 'లెటర్స్' మ్యాప్ నకలు, కాల. నర్సవ్వయ్య గంగయ్య ప్లాట్ నం: 125 తోబాటు తాళ్ళపల్లి షోరూమ్ ప్రాంతానికి పంపించారు వారి సర్టిఫై చేసిన మ్యాప్ నకలు. ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 11-11-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 16-09-2021 at 12:00 P.M.

The case is called on 16-09-2021. The appellant is absent. The PIO / Sri V. Mohan, Junior Assistant, O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District is present and stated that the information was furnished to the appellant vide letter No: G1/RTI/1203/2021 dated: 14-09-2021 and filed a copy of the information furnished to the appellant along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 23-09-2020 seeking information on 2 points. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
