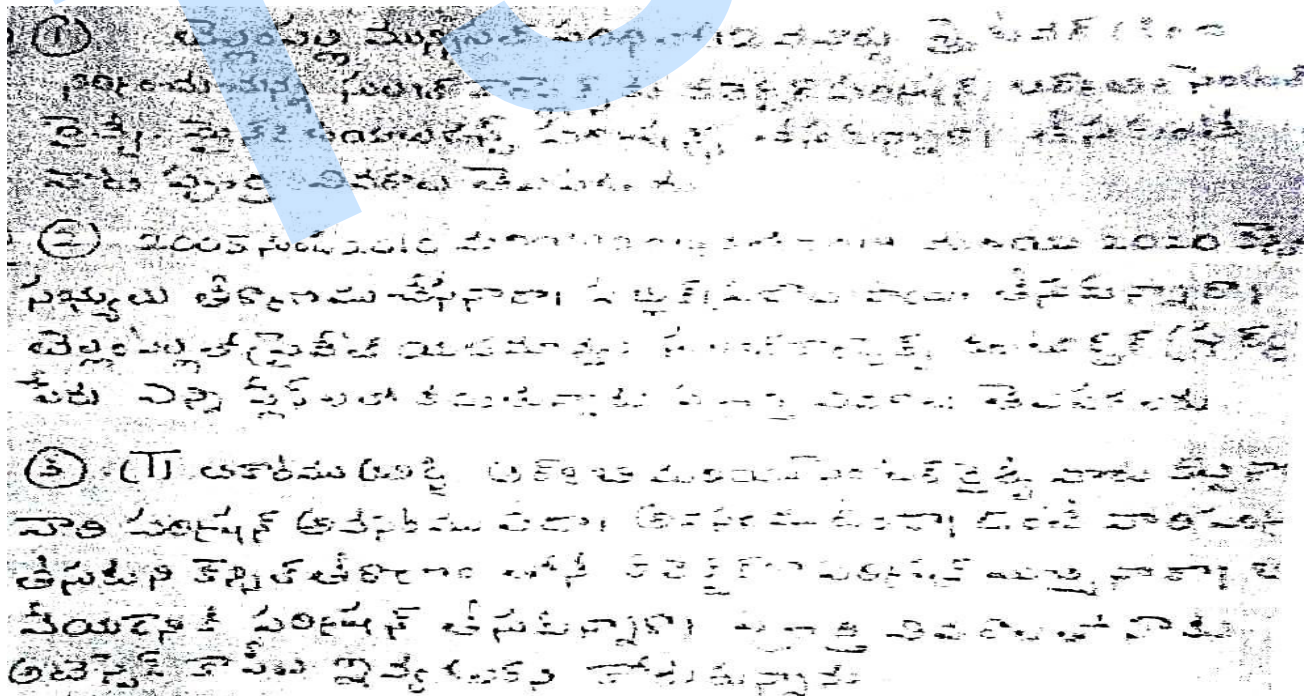

Order

Sri K. Manoj Kumar Reddy, Mancherial District has filed 2nd appeal dated: 01-12-2020 which was received by this Commission on 05-12-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Bellampally Municipality, Mancherial District and 1st Appellate Authority / O/o the Municipal Commissioner, Bellampally Municipality, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 23-07-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:



Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the 1st Appellate Authority has not taken action to hear the appeal and pass appropriate orders.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 13-08-2021 at 10.30 A.M.

The case is called on 13-08-2021. The appellant is present and stated that the PIO has not furnished the information. The APIO / Sri Md. Sarwar, Senior Assistant, O/o the Municipal Commissioner, Bellampally Municipality, Mancherial District is present and submitted that the information was furnished to the appellant vide letter No: RTI/45/2020 dated: 24-08-2020 and filed the copy of the information furnished, but failed to submit the postal evidence before the Commission.

Heard both the parties and perused the material paper available on record and observed that the appellant through his 6(1) application dated: 23-07-2020 seeking information on 3 points and the PIO has not furnished the copy of the resolution of the Municipal Council.

The Commission directs the PIO to furnish the copy of the resolution of the Municipal Council to the appellant immediately from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
