## **Order**

Sri Mohd. Fareeduddin, Hyderabad has filed a Complaint dated: 07-12-2020 which was received by this Commission on 08-12-2020 for not getting the information sought by him from the PIO / O/o the Deputy Educational Officer, Musheerabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 03-11-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- 1) Please Furnish the I Q International School Correspondent submission proposal copies for ETR.
- 2) Please Furnish the inspection report with check list.
- 3) Please Furnish the copy of the PTO, ETR of IQ International Upper Primary school Warisguda Secunderabad.
- 4) Please Furnish the check list of I Q International pre primary School Warisguda Secunderabad
- 5) Please Furnish the copies of PTO, ETR of I Q International pre primary School Warisguda.
- 6) Please Furnish the NOC's of GHMC, Traffic, Fire, Soundness, and Ground Permission of IQ International Upper Primary school, Warisguda, Secunderabad.
- 7) Please Furnish the status of DEO Proc. Rc. No. 4963/A5/2020 Dated 22-01-2020 to close the I Q International School, Warisguda Secunderabad up to Till today.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 13-08-2021 at 10.30 A.M.

The case is called on 13-08-2021. The complainant is present and stated that the PIO has not furnished the complete information. Sri. P. Chandra Shekar, Junior Assistant is present on behalf Sri M. Samuel Raj, Deputy Inspector of Schools, Musheerabad Zone, Hyderabad stating that the information was furnished to the complainant vide letter No: 448/Dy.EO/MSRD/2020 dated: 27-11-2020 and on receipt of the Commission notice dated: 23-07-2021 point wise reply was given to the complainant vide letter No: 443/Dy.EO/MSRD/2021 dated: 07-08-2021 and filed the copies of the information furnished to the complainant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant through his 6(1) application dated: 03-11-2020 seeking information on 7 points and the PIO has not furnished the complete information for Point No: 6.

The Commission directs the PIO to furnish the information for point No: 6 as sought through his 6(1) application dated: 03-11-2020 to the complainant within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
