Order

Sri. M.A. Saleem, Kamareddy District has filed a Complaint dated: 08-12-2020 which was received by this Commission on 09-12-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Sadashivnagar Mandal, Kamareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 21-03-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

I am in need of certain information in respect of Sy.No.890 ext.0.16 Gts, situated at Timmanagar Kunta, S.S.Nagar village.

Please furnish Adangal Pahani for the above land, from 1990-91 to 2019-2020 in respect of above land each pahani for five years gap which is stands on the name of, year, and please furnish that Endowment department land having on the above area, please name and extent, and year.

Please furnish the information Ryathu Bandu scheme, cheques issued by the T.S.Govt. furnish names, amount, and cheque numbers. of Sy.No.890.

Hence I request to kindly furnish the above information within the stipulated period, to me by Regd.Post to me.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 01-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 01-07-2021 with prior intimation to the concerned parties. The complainant did not respond. The PIO / Sri. Ravi, Deputy Tahsildar, Sadashivanagar Mandal, Kamareddy District responded and submitted that the information was furnished to the complainant vide letter No: A/237/2021 dated: 28-06-2021 and filed a copy of the information furnished before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 21-03-2020 seeking information. The PIO ought to have furnished the available information or should have given a specific reply informing the factual position to the complainant.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Deputy Tahsildar, Sadashivanagar Mandal, Kamareddy District for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the complaint is closed.
