## **Order**

Sri C. Kiran, Nizamabad District has filed 2<sup>nd</sup> appeal dated: 07-12-2020 which was received by this Commission on 10-12-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Kamareddy Mandal & District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Kamareddy Division, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 19-10-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) కామారెడ్డి మండలం ఇల్లిపూర్ గ్రామ నివాసురాలు కుర్యపెద్ద బీరమ్మ, భర్త రాజయ్యకు గామ శివారులో సర్వేనం. 133లో 0.10 గుంటల భూమిని గత 50 సం॥ల నుండి ఈ రోజు వరకు వారి కుటుంబ సభ్యుల కబ్జాలో ఉన్నదని ఇట్టి భూమికి పట్టా పాస్‌బుక్‌లు ఇమ్మని తేడి. 05.10.2020న రోజున దరఖాస్తు ఇచ్చినారు. దీనిపై ఈ రోజు వరకు తమరు తీసుకున్న రోజు వారి స్థితిగతులు మొత్తం వివరముల ప్రతులు జిరాక్స్ చేసి ధృవీకరించి ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 19-11-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 08-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 08-07-2021 with prior intimation to the concerned parties. The representative of the appellant responded and stated that the PIO has not furnished the information.

The PIO / Sri. P.V. Srinivas, Deputy Tahsildar, Kamareddy Mandal, Kamareddy District responded and stated that a reply was given to the appellant vide letter No: A/3100/200 dated: 26-11-2020 and filed a copy of the letter before the Commission.

Heard both parties and perused the material paper available on record and observed that the appellant filed 6(1) application dated: 19-10-2020 seeking information on the action taken on the compliant filed on 05-10-2020 and the PIO submitted that a reply was given on 26-11-2020, but postal receipt shows that the information was sent on 06-07-2021.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Deputy Tahsildar, Kamareddy Mandal, Kamareddy District for not furnishing the information to the appellant. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to give a specific reply on against the action taken on the complaint dated: 05-10-2020 to the appellant (Keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) through Registered post acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
