Order

Sri. M. Dowlath, Kumrambheem Asifabad District has filed a Complaint dated 25-11-2020 which was received by this Commission on 11-12-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Wankidi Mandal, Kumarambheem Asifabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 23-10-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Hence I request you to kindly issue there the following records under section 7 (1) of the Right to Information Act 2005. I am enclosed here with a postal order in favour of Tahashildar, WANKIDI bea no. 56H 597431 dt. 11.10.2019 value Rs. 100/- (One hundred only) as required for the relating information.

1. Form No. 7 → VAO
 2. 1B → VAO
 3. Phasal patti & documents along with proceedings. → OK ✓ No-4
 4. Position before changes & after changes of the sy. no. 5/03 → OK ✓ Pabani
 5. Mutation file and note file copies. → VAO ✓
 6. Certified copy of the applicant application. → VAO
 7. Names, address and designation of officers i.e. VRO, MRI, DT and Tahashildar for who has order to change / transferred my patta land. → VAO ✓ OK
 8. Panchanama copy if conducted → VAO
- Kindly issue the above at an early date
encl. Postal order No. 56H. 597431 Rs. 100/-

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 01-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 01-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information. The PIO / Sri. Heeralal, Deputy Tahsildar, Wankidi Mandal, Komaram Bheem Asifabad District responded and stated that the information was furnished to the appellant vide letter Rc. No: A/19/2019 dated: 11-01-2021 and filed a copy of the information furnished to the appellant before the Commission.

Heard both the parties and perused the material papers available on record. The appellant submitted that the Ownership names in his Pattadar Passbook were illegally changed to some other person and the PIO has wontedly delayed in furnishing the information.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Deputy Tahsildar, Wankidi Mandal, Komaram Bheem Asifabad District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to arrange for verification of records on a mutually convenient date and time by issuing prior intimation to the appellant to enable him to obtain the required information within Two (2) Weeks from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.
