Order

Sri Abdul Moheed, Hyderabad has filed a Complaint dated 10-12-2020 which was received by this Commission on 11-12-2020 for not getting the information sought by him from the PIO / O/o the Regional Joint Director of School Education, Nampally, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 19-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Particulars of Information sought:

- [1] Photocopy of the acknowledgement attached to this letter.
- [2] Certified copy of the periodical progress report of my letter in respect of above mentioned.
- [3] Please provide me the Name, Designation, Office Address and Phone Number of the Concerned Officer(s) entrusted with the inspection of the complaint with respect to above mentioned.
- [4] Certified copy of the said report as prepared by the concern officer in respect of above mentioned.
- [5] Please supply me the copy of enquired and/or response of correspondent and/or witnesses recorded during the course of inspection, based on which the report and findings were drawn by the concern officer.
- [6] If the correspondent were not enquired or their statements not recorded, please supply me certified copy of documents based on which the findings of facts was drawn by the concerned Officer.
- [7] Certified copy of your rules or citizens charter or any other documents stipulating the time frame in number of days, by which such a complaint/matter should have been dealt with and inspected by your public authority.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The complainant is absent. Sri N. Rohit, Junior Assistant is present on behalf of the PIO / Sri A. Sai Purna Chander Rao, Assistant Director, O/o the Regional Joint Director of School Education, Hyderabad stating that based on the complaint of the complainant an enquiry was called for from the District Educational Officer, Hyderabad vide letter Rc. No: 1858/A2/Shifting/2019 dated: 16-07-2019 and the enquiry is still under process and vide letter Rc. No: 1435/A2/2020 dated: 28-05-2021 the District Educational Officer, Hyderabad was requested to submit a detailed report along with specific remarks for taking further necessary action in the matter. The PIO filed the copy of the letters communicated before the Commission.

Perused the material papers available on record.

The Commission directs the PIO to give a specific reply to the complainant informing the factual position within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
