## **Order**

Sri Mohd Furrug Jahangir, Hyderabad has filed a Complaint dated: -12-2020 which was received by this Commission on 11-12-2020 for not getting the information sought by him from the PIO / O/o the Telangana State Consumer Disputes Redressal Commission, Khairtabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 22-10-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

You, The State Consumer Disputes Redresser Commission, Telangana State found my case CC SR No. 1576 of 2019 as not maintainable after my payment of prescribed fee of Rs. 4,000 through Indian Bank DD No. 72608 dated 17/05/2019. Thereafter I wrote to You on date 8 August 2019 i.e. 14 months ago and followed it up with written reminders dated 27 September 2019 and again on 17 September 2020 ALL DULY ACKNOWLEDGED for refund of Complaint Fee stated above. I also wrote an eMail dated 28 August 2020 all to NO AVAIL i.e. neither a reply was given nor refund issued to date.

Therefore, please by what date will You, viz. The State Consumer Disputes Redresser Commission, Telangana State refund my Complaint Fee of Rs. 4,000 (rupees four thousand only)?

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M.

The case is called on 26-08-2021. The complainant is absent. The APIO / Sri K. Ravi Prakash, Sheristdar is present on behalf of the PIO / Sri N. Ramkumar, PA to President-cum-PIO, O/o the TSCDRC, Hyderabad stating that the information was furnished to the complainant vide letter No: dated: 05-12-2020 and filed the copies of the information furnished to the complainant before the Commission.

Heard the APIO and perused the material papers available on record and observed that the PIO has furnished information to the complainant.

Since the information is furnished, the complaint is closed.
