Order

Sri Sabir Ahmed Khan, Mancherial District has filed 2nd appeal dated: 12-12-2020 which was received by this Commission on 15-12-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Chennur Municipality, Mancherial District and 1st Appellate Authority / O/o the Municipal Commissioner, Chennur Municipality, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 14-09-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- ① As on today with our layout permission layouts are (3)th with in Area (28) Acres in the Old equal Government of the Clear area of News Paper Land 13/2
 - ② In need of Survey Members with Area of (28) Acres.
 - ③ Furnish a list of Papers of above Survey Members.
 - ④ Whether the above lands are Govt Assessor lands. or - Gaudobasth B- the lands.
- one information

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 04-12-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 13-08-2021 at 10.30 A.M.

The case is called on 13-08-2021. The appellant is absent. The PIO / O/o the Municipal Commissioner, Chennur Municipality, Mancherial District is absent.

Perused the material papers available on record and observed that the appellant filed 6(1) application dated: 14-09-2020 seeking information on 4 points.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO / Sri R. Satish Kumar, Town Planning Section, O/o the Municipal Commissioner, Chennur Municipality, Mancherial District and the then PIO / Sri Santosh, Town Planning Section, O/o the Municipal Commissioner, Chennur Municipality, Mancherial District for not furnishing the complete information to the appellant. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the present PIO to furnish the complete information to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
