## Order

Sri G.V. Ramana Reddy, Hyderabad has filed 2<sup>nd</sup> appeal dated: 14-12-2020 which was received by this Commission on 17-12-2020 for not getting the information sought by him from the PIO / O/o the District Civil Supplies Officer, Assistant District Civil Supply Officer, Ranga Reddy District Collectorate, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the District Civil Supplies Officer, Assistant District Civil Supply Officer, Ranga Reddy District Collectorate, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 21-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

పేరు మరియు అధికారి నుండి ఆ కుటుంబ సభ్యులను గురించిన వివరాలను  
ఇవ్వాలని ప్రార్థనలు చేయడం. Rs. 10/- + 10/- కుటుంబ అధికారి  
కామ్రా ద్వారా చెల్లించాలి.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 14-09-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M.

The case is called on 26-08-2021. The appellant is present and stated that the PIO has not furnished the information. Sri Manohar Kumar Rathod, District Civil Supplies Officer, Ranga Reddy District is present and filed his affidavit stating that vide letter No: A5/316/2020 dated: 09-09-2020 the appellant was informed that the information sought is presently not available. The PIO filed the copy of the information furnished before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant through his 6(1) application dated: 21-08-2020 seeking information regarding the ration card details of Sri S. Rami Reddy from the year 1980 to 2005 and the PIO submitted that the information sought is of 40 years and the same would be destroyed periodically.

The Commission directs the PIO to give a specific reply along with the copy for the destruction of the records to the appellant within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
