Order

Sri Thota Kiran Kumar, Karimnagar District has filed a Complaint dated: Nil which was received by this Commission on 25-01-2020 for not getting the information sought by him from the PIO / the Gram Panchayat Secretary, Bommakal Village, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 03-12-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

The PIO vide Lr. No. RTI/644/2019, dated. 09-12-2019 furnished the information to the Complainant.

Aggrieved with the reply from the PIO, the complainant preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 13-08-2021 at 10.30 A.M.

The case is called on 13-08-2021. The complainant is absent. The PIO / Sri B. Surender, Panchayat Secretary, Bommakal Village, Karimnagar District is present and filed his affidavit stating that a reply was given to the complainant vide letter No: GP/BMK/RTI/60/19 dated: 10-01-2020 and filed a copy of the information furnished along with the acknowledgement of the complainant before the Commission.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 03-12-2019 seeking information on 3 points and the PIO vide letter dated: 10-01-2020 informed that the information sought is not available in their office. The Commission is of the view that the PIO ought to have transferred the application to the concerned Public Authority or should have informed from where the information can be obtained.

The Commission directs the PIO to make a through search and give a specific reply to the complainant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
