Order

Smt. Ayesha Fatima, Hyderabad has filed a Complaint dated: -12-2020 which was received by this Commission on 24-12-2020 for not getting the information sought by him from the PIO / Land Acquisition Officer, O/o the Deputy Commissioner, GHMC, Circle.10, Sardar Mahal, Falauknama, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 24-10-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

a) Please furnish me the copies of Land Acquisition award passed by your office pertaining to Municipal No. 19-2-539/A, outside Fateh Darwaza, Hyderabad and any other documents connected with the Land Acquisition proceeding for the said Municipal and other numbers.

5. Kindly provide the certified/attested copies, and provide the delivery in person, I am ready to pay the requisite fee for furnishing the information.

6. The information can be furnished within 30 days as prescribed under Section 6 (1)/ the Information ACT.

And more few points.

The PIO has not furnished the information to the Complainant.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The complainant is present and filed her affidavit stating that the PIO has not furnished the information. The PIO / Sri Abdul Faheem, Assistant City Planner, O/o the Deputy Commissioner, GHMC, Circle No: 9, Sardar Mahal, Hyderabad is present and filed his affidavit stating that a reply is brought to the Commission vide letter No: RTI/ACP/C9/CZ/GHMC/2021 dated: 01-09-2021 filed a copy of the reply before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 29-10-2019 seeking certain information.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO / Sri Abdul Faheem, Assistant City Planner, O/o the Deputy Commissioner, GHMC, Circle No: 9, Sardar Mahal, Hyderabad and the then PIO / Assistant City Planner, O/o the Deputy Commissioner, GHMC, Circle No: 9, Sardar Mahal, Hyderabad for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of RTI. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to give a specific reply to the complainant informing the factual position within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
