Order

Sri MV. Manoj Kuamr, Hyderabad has filed 2nd appeal dated: Nil which was received by this Commission on 28-12-2020 for not getting the information sought by him from the PIO / O/o the Telangana State Industrial Infrastructure Corporation Ltd., Basheerbagh, Hyderabad and 1st Appellate Authority / O/o the Telangana State Industrial Infrastructure Corporation Ltd., Basheerbagh, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 17-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- District and trade Towers, Man...*
- (1) All the pertaining to the issue of of Manchoivula Business District
 - (2) All Correspondence between Reliance & seek the information u/RTI Act 2005 details which are provided below
- * All files pertaining to the issue Manchoivula Business dist
 - * All Correspondence between Reliance energy ltd & APIC (TSIC)
 - * Copy of Agreement between APIC (TSIC) and the highest bidder i.e Reliance energy ltd. for the execution of the project as per the finalization terms and conditions
 - * Terms of payment towards the cost of loan, Equity Debentures etc and penalties thereon for delay
 - * Latest Correspondence between TSIC & Reliance Energy Ltd year's financials

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 25-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 13-08-2021 at 10.30 A.M.

The case is called on 13-08-2021. The appellant is absent. Smt. B. Sunita Bai, Chief General Manager (AM) and Sri K. Shyam Sunder, Chief Engineer, O/o the Telangana State Industrial Infrastructure Corporation Ltd., Basheerbagh, Hyderabad are present and stated that vide letter No: 47347/RTI Act, 2005/TSIIC/Appeal-07/2020 dated: 10-11-2020 the appellant was requested to visit their office on 06-11-2020 for hearing and was informed that the matter is under examination by the Government. The PIO filed a copy of the same along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to give a specific reply to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
