Order

Smt. Belly Laxmi, Hyderabad has filed 2nd appeal dated: 28-12-2020 which was received by this Commission on 28-12-2020 for not getting the information sought by him from the PIO / O/o the Commissioner of Civil Supplies, Civil Supplies Department, Erramanzil, Hyderabad and 1st Appellate Authority / O/o the Commissioner of Civil Supplies, Civil Supplies Department, Erramanzil, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 03-10-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Please provide the complete **CERTIFIED / ATTESTED** copies of **ACTION TAKEN REPORT** in respect of reference cited. A copy of reference cited is enclosed for kind perusal.
- 2) Please provide the complete **CERTIFIED / ATTESTED** copies of **Lr. No. A5/181/CS/2020, Dated: 09-07-2020** from District Civil Supplies Officer, Ranga Reddy District addressed to **Commissioner of Civil Supplies, Civil Supplies Bhavan, Telangana, Erramanzil, Hyderabad.**
- 3) Please provide the complete **CERTIFIED / ATTESTED** copies of **ACTION TAKEN REPORT** in respect of **Lr. No. A5/181/CS/2020, Dated: 09-07-2020** from District Civil Supplies Officer, Ranga Reddy District addressed to Commissioner of Civil Supplies, Civil Supplies Bhavan, Telangana, Erramanzil, Hyderabad, and if the action on above stated letter is still under process (as informed in previous RTI reply vide CCS Ref. M&C.II/RTI/1399/2020, Date: 26-08-2020 from your kind office), then please provide me the **CERTIFIED / ATTESTED** copies of relevant rules in force pertaining to disposal of letters by O/o Commissioner of Civil Supplies, Telangana, Hyderabad received from concerned officials of Civil Supplies Department.
- 4) Please provide the complete **CERTIFIED / ATTESTED** copies of rules adopted by this department for granting the New Food Security Card to the concerned individuals.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 20-11-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M.

The case is called on 26-08-2021. The appellant is absent. The PIO / Smt. A. Usha Rani, Joint Commissioner, O/o the Commissioner Civil Supplies, Hyderabad is present and filed her affidavit stating that the information was furnished to the appellant vide letter No: CCS.Ref.M&C.II/RTI/1399/2020 dated: 26-08-2020 and filed the copy of the information furnished along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant through his 6(1) application dated: 03-10-2020 seeking information on 6 points and the PIO has furnished the information.

Since the information is furnished, the appeal is closed.
