## **Order**

Sri Pavahar Yaswanth Rao, Kamareddy District has filed 2<sup>nd</sup> appeal dated: 28-12-2020 which was received by this Commission on 29-12-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Yellareddy Municipality, Yellareddy, Kamareddy District and 1<sup>st</sup> Appellate Authority / O/o the Municipal Commissioner, Yellareddy Municipality, Yellareddy, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 19-09-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

I humbly submit a few lines to the kind authority that, Provide me the complete certified information current and note file of action taken on representations dated 23/11/2019 and 10/07/2020 in regard government collage land encroachment in sy no 459 by kudmula satyanarayana under RTIA 2005 in person (By Hand).

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 13-11-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 16-09-2021 at 12:00 P.M.

The case is called on 16-09-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Smt. B. Vasanthi, Manager and Sri J. Jagjeevan, Municipal Commissioner, Yellareddy Municipality, Kamareddy District are present and requested to give time to furnish the information.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 19-09-2020 seeking information to furnish the certified copies of Current & Note File on the action taken on his representation dated: 23-11-2019 & 10-07-2020 with regard to Government College land encroachment in Sy. No: 459. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the action taken on his representation dated: 23-11-2019 & 10-07-2020 to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
