Order

Sri K. Ramu, Karimnagar District has filed a Complaint dated: 30-09-2019 which was received by this Commission on 01-10-2019 for not complying the Commission order in appeal No: 13083/CIC/2017 dated: 23-04-2018 and for not getting the information sought by him through his 6(1) application dated: 13-12-2016 from the PIO – I / O/o the Gram Panchayat, Asif Nagar Village, Karimnagar District & PIO – II / O/o the DPO, Karimnagar District.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 05-08-2021 at 10.30 A.M.

The case is called on 05-08-2021. The complainant is present and stated that the PIO has furnished incomplete information. The PIO / Sri V. Sridhar, Panchayat Secretary and Sri. B. Rajeshwar, Administrative Officer, O/o the DPO, Asifnagar Village, Karimnagar Mandal & District are present and filed affidavits stating that point wise reply was given to the complainant vide letter No: dated: 30-07-2021 and the same was furnished to the complainant by hand on 04-08-2021. The PIO filed a copy of the same along with the acknowledgement of the complainant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the Commission in earlier complaint No: 13083/CIC/2017 dated: 23-04-2018 directed the PIO to furnish the information to the complainant within 2 weeks and report compliance.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO & the then PIO / Panchayat Secretary, Asifnagar Village, Karimnagar Mandal & District for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the complaint is closed.
