Sri Fakhruddin, Hyderabad has filed a Complaint dated 24-08-2018 which was received by this Commission on 25-08-2018 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 14-06-2018 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Ref: My SR 1863/18 filed at XIV Metropolitan Magistrate Nampally Hyderabad returned stating "How a male/Husband can file a petition under provision of PWDVACT"

Respected PIO/Registrar General,

1. Kindly give information can Husband file DVC on his wife under article 12 of domestic violence act 2005 after Hon'ble Apex court order in Civil Appeal 10084/2016 in HIRAL P. HARSORA and ors VS KUSUM NAROTTAMDAS HARSORA and ORS. Please answer in yes and NO.
2. Considering answer to above point 1st is NO. Please let me know how below application are running in Aurangabad JMFC Court under article 12 of domestic violence act 2005

And more few points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices are issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case is called on 03-09-2021. The complainant is absent. Sri J. Anil Kumar, Standing Counsel for O/o the Registrar Judicial, High Court of Telangana, Hyderabad is present and submitted that a reply was given to the complainant vide letter ROC. No: 441/PIO/JUDL /2018 dated: 07-08-2018 and filed a copy of the order before the Commission.

Perused the material paper available on record and observed that the information sought by the complainant is not as per section 2(f) of RTI Act 2005 and is hypothetical.

Upholding the reply given by the PIO, the complaint is closed.
