Order

Sri S. Anjaiah, Nalgonda District has filed 2nd appeal dated: 04-11-2019 which was received by this Commission on 04-11-2019 for not getting the information sought by him from the PIO / District Revenue Officer, O/o the District Collector, Nalgonda District and 1st Appellate Authority / O/o the Joint Collector, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 08-04-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. ఇట్టి ఫిర్యాదుపై నేటి వరకు ఎమెమ్మి చర్యలు తీసుకున్నారో పూర్తి నమాచారం తెలువగలరు.
2. మేము ఇచ్చిన ఫిర్యాదును పరిష్కరించారా లేదా. ఒకవేళ పరిష్కరించినట్లయితే వాటి కాపీలు జీరాక్యుల రూపంలో ధృవీకరించి ఇవ్వగలరు.
3. మేము ఇచ్చిన ఫిర్యాదులను పరిష్కరించినట్లయితే ఎందుకు పరిష్కరించలేదో, దానికి గల కారణాలు తెలియజేస్తూ మాకు పూర్తి నమాచారం ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 15-05-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 05-08-2021 at 10.30 A.M.

The case is called on 05-08-2021. The appellant is present and stated that the PIO has not furnished the information. Sri. V. Chandra Shekhar, Additional Collector, Nalgonda District and Sri V. Venkateshwarlu, District Civil Supply Officer, Nalgonda District are present and stated that the information was furnished to the appellant on 31-05-2019 and filed the copies of the same, but failed to submit the postal evidence before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant through his 6(1) application dated: 08-04-2019 seeking information on the action taken on his complaint dated: 21-02-2019. Upon not filing the documentary evidence the Commission cannot accept the submissions of the PIO.

The Commission directs the PIO to furnish the information relating to the action taken on the complaint dated: 21-02-2019 (keeping in view of Section 8, 9, 10 & 11 of RTI Act 2005) to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
