Order

Sri. G. Nikhil, Wanaparthy District has filed 2nd appeal dated: 02-02-2020 which was received by this Commission on 05-02-2020 for not getting the information sought by him from the PIO / O/o the District Collector, Wanaparthy Collectorate, Wanaparthy District and 1st Appellate Authority / O/o the District Collector, Wanaparthy Collectorate, Wanaparthy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 15-10-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

2. ద్యారపోగు వజ్రమ్మ భర్త కీ||శే|| ద్యారపోగు వుశనయ్య వనపర్తి మరియు ఇతర 6 మంది ఫిర్యాదు దారులు తేది.06-08-2014 రోజున చేసిన Stay Order పిటిషన్ లో LR గా గోర్ల రామస్వామి తండ్రి కీ||శే|| గోర్ల తిమ్మన్న పేరును మరియు Respondent గా పేర్కొనబడిన క్రమ సంఖ్య 4 మరియు 5 గారల తండ్రులను తప్పుగా పేర్కొనగా అట్టి పిటిషన్ ను విచారణకు అర్హత కలిగిన దానిగా ఎలా స్వీకరించారో సమాచారము ఇవ్వగలరు.
3. కీ||శే|| గోర్ల తిమ్మన్న గారికి LR s 9 మంది వారసులు జీవించి వున్నారు. 9 మంది LR s జీవించి వుండగా మరియు వారందరు AP (TA) Inam Abolition Act - 1955 చట్ట ప్రకారము విచారణకు అర్హత కలిగివుండగా - కేవలం (3) ముగ్గరికి మాత్రమే విచారణకు హజరు కమ్మని నోటీసులు జారీచేశారు. మిగతా 6 మంది వారసులకు ఎందుకు విస్మరించారో, వారికి ఎందుకు నోటీసులు పంపించలేదో సమాచారము ఇవ్వగలరు.

And more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 15-12-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 06-08-2021 at 10.30 A.M.

The case is called on 06-08-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri K. Venkat Krishna, Administrative Officer, O/o the District Collector, Wanaparthy Collectorate, Wanaparthy District is present and filed affidavit stating that the information sought is brought to the Commission and is ready to be furnished to the appellant.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 16-10-2019 seeking information on 5 points. The PIO vide letter No: RTI/723/2021 dated: 05-08-2021 furnished the information to the appellant before the Commission with acknowledgement by the appellant.

The Commission took a serious view and directs to issue **Show Cause Notice** to the then deemed PIO / Sri M. Srinivas Rao, Superintendent, E-Section, O/o the District Collector, Wanaparthy Collectorate, Wanaparthy District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
