Revised Order

Sri Y. Ananda Rao, Khammam Distirct has filed 2nd appeal dated: 05-12-2018 which was received by this Commission on 10-12-2018 for not getting the information sought by him from the PIO / O/o the Chief Administrative Officer, Prl. District & Session Court, Khammam District and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 25-09-2018 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 06-10-2018 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices are issued to both the parties for hearing on 17-09-2021 at 10.30 A.M.

The case is called on 17-09-2021. The appellant is absent. The PIO / Superintendent, O/o the Chief Administrative Officer, Judicial Magistrate of First Class Court, Khamman District is absent. Sri Anand Kumar Kapoor, Standing Council representing the First Appellate Authority / O/o the Registrar General, High Court of Judicature at Hyderabad, State of Telangana, Hyderabad is present and stated that a reply was given by the SAPIO / CAO, District Court, Khammam District to the appellant vide Proc. Order Dis. No: 5298/TI/Adm/DCK dated: 01-10-2018. Upon filing the 1st appeal, the First Appellate Authority / Registrar General, High Court of Judicature at Hyderabad, Hyderabad passed an order vide appeal No: 177 of 2018 dated: 06-11-2018 and informed the appellant to file a Copy Application in the concerned court for issuance of Certified copy of the said document.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO / Superintendent, O/o the Chief Administrative Officer, Judicial Magistrate of First Class Court, Khamman District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005 and for not appearing before the Commission for the hearing held on 17-09-2021. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the PIO and the First Appellate Authority informed the appellant about the procedure of procuring the documents, the appeal is closed.
