Order

Ms. Zainab Parveen, Hyderabad has filed 2nd appeal dated: 03-10-2017 which was received by this Commission on 29-01-2018 for not getting the information sought by her from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 29-08-2017 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

That a suit has been filed against me and my family members in O.S.No: 91 of 2017 on the file of the XI Addl. Chief Judge, City Civil Court, Hyderabad seeking perpetual injunction against us in respect of premises number 22-7-259 & 261 and other properties situated at Deewan Devdi, Hyderabad I am told that we have to get the information with regard to title standing in the name of vendor of our property. As a matter of fact a compromise Decree for partition was affected in C.S.No: 13 of 1958 and we have purchased part of the land i.e., premises number 22-7-259 & 261 situated at Deewan Devdi, Hyderabad from one of the party in C.S.No: 13 of 1958. To prove our possession and ownership it has become necessary to get the particulars of our vendor Syed Hasan, Syed Kazim Hussain, Syed Ahmed, Syed Abdul Waheb, Putli Begum, Nawab Turab Yar Jung Bahadur, Nawab Sajid Yar Jung, Sultan Jehan Begum, Bilquis Jahan Begum, Salar Jung Committee, The Jagir Administrator, Government of Hyderabad,

And more few points.

The PIO vide Roc No.708/PIO/JUDL/2017 dated: 12-09-2017 furnished the information to the appellant.

Aggrieved with the reply from the PIO, the appellant filed 1st appeal dated: 29-12-2018 before the 1st Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing her 1st appeal, she preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case is called on 03-09-2021. The complainant is absent. Sri J. Anil Kumar, Standing Counsel for High Court, O/o the Registrar Judicial, High Court of Judicature at Hyderabad, State of Telangana, Hyderabad is present and filed affidavit stating that a reply was given to the appellant vide letter Roc. No: 708/PIO/JUDL/2017 dated: 12-09-2017 and First Appellate Authority through appeal No: 155 of 2017 dated: 27-10-2017 informed the appellant that seeking permission to verify the record in a pending case in High Court is not tenable and further informed that the information sought is of 3rd party to the said case and the appellant has failed to show the involvement of larger public interest to justify granting the permission. The First Appellate Authority upheld the reply of the PIO and dismissed the appeal.

Perused the material papers available on record.

Keeping in view above, the Commission up holds the reply of the PIO and the First Appellate Authority, the appeal is closed.
