Order

Sri A. Saibaba, Kamareddy District has filed 2nd appeal dated: 10-02-2020 which was received by this Commission on 12-02-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Nasurullabad Mandal, Kamareddy District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Banswada Division, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 15-11-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. నామమాటాబాద్ మండల పరిధిలో గల కంశెట్ పల్లి శివారు ఎన్ని ఎకరాలు, ఎన్ని సర్వే నెంబర్లు, శివారు యొక్క సక్ష కాపీలపై గెజిటెడ్ సంతకంతో సంపూర్ణ సమాచారం అందించగలరు.
2. కంశెట్ పల్లి శివారు రాజరాజేశ్వర గుట్ట దరిదాపులో సరిహద్దు చుట్టూ ఉన్న సర్వే నెంబర్ విస్తీర్ణము ఎంత.
3. కంశెట్ పల్లి శివారులో అసైన్డ్ భూమి ఎంత ? ఇనాం భూమి ఎంత ? పరారీ పట్టా ఎంత ? ఫారెస్టు భూమి ఎంత ? పట్టా భూమి ఎంత ? మిగులు భూమి యొక్క సర్వే నెంబర్, విస్తీర్ణము యొక్క సంపూర్ణ సమాచారం అందించగలరు.
4. 2000 సంవత్సరం నుండి 2019 వరకు రెవెన్యూ శాఖ నుండి ఎంత మందికి ప్రభుత్వ భూమి పట్టాలు మంజూరు చేసిన పట్టా సర్టిఫికేట్ పహనీ నకల్, పాజిషన్ సర్టిఫికేట్, ఓనర్ షిప్ సర్టిఫికేట్, యజమాని హక్కు పత్రము, పాస్ బుక్ జిరాఫ్స్ కాపీలపై గెజిటెడ్ సంతకాలతో సమాచారం అందించగలరు.
5. జిల్లా కలెక్టర్, జాయింట్ కలెక్టర్, ఆర్డీవో, తహసీల్దార్, ఆర్ఐఐ, సర్వేయర్, విఆర్వో ఫోన్ నెంబర్ల సమాచారం అందించగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 28-12-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 27-08-2021 at 10.30 A.M.

The case is called on 27-08-2021. The appellant is absent. The PIO / Sri D. Venkanna, Deputy Tahsildar, Nasurullahbad Mandal, Kamareddy District is present and filed his affidavit stating that the information sought was prepared vide letter No: A/47/2020 dated: 13-03-2020, but since there is no postal evidence, the same was sent again on 24-08-2021. The PIO filed copies of the information furnished along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 15-11-2019 seeking information on 5 points. Upon not filing the documentary evidence of furnishing the information on 13-03-2020 the Commission cannot accept the submissions of the PIO.

The Commission took a serious view and directs to issue **Show Cause Notice** to the then PIO / Sri K. Gangadhar, Deputy Tahsildar, Nasurullahbad Mandal, Kamareddy District presently working as Tahsildar, Banswada Mandal, Kamareddy for not furnishing the complete information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
