Order

Smt. G. Laxmi, Siddipet District has filed 2nd appeal dated: Nil which was received by this Commission on 02-01-2020 for not getting the information sought by her from the PIO / O/o the Mandal Parishad Development Officer, MPP Siddipet Rural Mandal, Siddipet District and 1st Appellate Authority / O/o the Mandal Parishad Development Officer, MPP Siddipet Rural Mandal, Siddipet District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 22-10-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application:

- (1) గ్రామం: మంచాపూర్ నిర్దిష్టమైన కులకర్ మండలం, నిర్దిష్టమైన చిట్టాలోని మంచాపూర్ రెవెన్యూ సబ్ డివిజన్ (మంచాపూర్ గ్రామ పంచాయతీకి సంబంధించిన) ఇంజనీరింగ్ డివిజన్, సెల్: (మంచాపూర్) కులకర్ మండలం, మంచాపూర్ రెవెన్యూ సబ్ డివిజన్, ఇంజనీరింగ్ డివిజన్, డివిజన్, 2015 సం॥ నుండి గ్రామంలో వసతి ఉందా? అనగా 22/10/2019 తరువాత మంచాపూర్ రెవెన్యూ సబ్ డివిజన్.
 - (2) మంచాపూర్ గ్రామ పంచాయతీ Certified Property Books. మంచాపూర్ డివిజన్ గ్రామంలో సంబంధించిన ఇంజనీరింగ్ డివిజన్ రికార్డులను ఉంచుతారా?
- కులకర్ మండలం గ్రామ పంచాయతీ మంచాపూర్ రెవెన్యూ సబ్ డివిజన్ డివిజన్ రికార్డులను మంచాపూర్ చిట్టా రికార్డులు, ఇంజనీరింగ్ డివిజన్ రికార్డులను ఉంచుతారా? CP Books.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 23-11-2019 before the 1st Appellate Authority requesting her to furnish the information sought by her u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 17-09-2021 at 12:00 P.M.

The case is called on 17-09-2021. The appellant is absent. The PIO / Sri B. Aravind, Mandal Panchayat Officer, MPP Siddipet Rural Mandal Siddipet District is present and stated that the information was furnished to the appellant on 19-10-2019 and filed the copies of the information furnished to the appellant before the Commission.

Heard the PIO and perused the material papers available on record and observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
