## Order

Sri. P. Raghuvver, Hyderabad has filed 2<sup>nd</sup> appeal dated: 02-08-2017 which was received by this Commission on 02-08-2017 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, GHMC, Circle-4B, Sardarmahal, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Zonal Commissioner, GHMC, South Zone, Charminar, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 10-05-2017 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. Whether the G.H.M.C. [the then M.C.H.] has purchased the above said land 4.22 Acres of Sy.No.242 of Gowlipaha ~~to~~ from the private persons;  
(a) If so, a copy registered sale deed to the above effect may be furnished with the Plan.
2. Whether the G.H.M.C. [the then M.C.H.] acquired the above said land from the Govt. or PRIVATE PARTY.  
(b) If so, the Acquisition Proceedings / Memo / G.O. / Letter to the above effect may be furnished with the Plan of the land.
3. Whether the Government [Revenue Dept.] has Alienated the said land in favour of G.H.M.C. [the then M.C.H.]  
(c) If so, the Alienation Proceedings from the concerned department, with its Memo or Letter or G.O. along with the Plan be furnished.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 28-06-2017 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The case was earlier heard on 08-08-2018 and again on 01-07-2021. In view of the Covid -19 Pandemic, the cases are heard over phone on 01-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information. The PIO / Sri. Mohan Reddy, Assistant Municipal Commissioner, Circle – 7, South Zone, GHMC, Hyderabad responded and stated that the appellant is seeking the document relating to the year 1961, even after through search the said information is not available in their office.

Heard both the parties and perused the material paper available on record.

The Commission directs the PIO to make a through search once again and give a specific reply by informing the factual position to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
