Order

Sri. P. Raghuveer, Hyderabad has filed 2nd appeal dated: 21-09-2017 which was received by this Commission on 21-09-2017 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, GHMC, Circle-4B, Sardarmahal, Hyderabad and 1st Appellate Authority / O/o the Zonal Commissioner, GHMC, South Zone, Charminar, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 05-07-2017 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Sub: Land of Sy.No. 242 at Goulipura- Certain Information sought under the RTI, Act 2005-Reg.

Ref.No.1: Letter No.463/RTI/EO/GHMC/2017, Dt. 31.05.2017.

2. Letter No. /DC, SZ/GHMC/2017, Dt. 01.07.2017.

Kind attention is invited to the references 1st & 2nd cited and I request the Public Information Officer and the Deputy Commissioner, Circle IV-B, GHMC to kindly arrange to furnish me the following photocopies of the documents mentioned here under, under the RTI Act, 2005, duly attested.

4. Registered sale deed document No.1827/1961, Dt. 21.08.1961 of the above subject land.
5. Plan of the land annexed to the sale deed.
6. Link document to the above sale deed.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 08-08-2017 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 01-07-2021 at 11.00 A.M.

The case was earlier heard on 22-11-2017, 05-01-2018, 12-04-2018 and finally on 01-07-2021. In view of the Covid -19 Pandemic, the cases are heard over phone on 01-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information. The PIO / Sri. Mohan Reddy, Assistant Municipal Commissioner, Circle – 7, South Zone, GHMC, Hyderabad responded and stated that the appellant is seeking the document relating to the year 1961, even after through search the said information is not available in their office.

Heard both the parties and perused the material paper available on record.

The Commission directs the PIO to make a through search once again and give a specific reply by informing the factual position to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
