Order

Sri R.B. Malikarjun, Sangareddy District has filed 2nd appeal dated: 25-09-2017 which was received by this Commission on 26-09-2017 for not getting the information sought by him from the PIO / O/o the Chief Ministerial Officer, Junior Civil Judge Court, Yellareddy, Kamareddy District and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 27-06-2017 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. According to RTI Act – 2005, it is mandatory for every public authority to display the **Name, Designation, Address and Contact Number of APIO, PIO & Appellate Authorities**. But, no such details had been displayed on the Notice-board or elsewhere at the Junior Civil Judge Court – Yellareddy as on date.
Kindly provide the necessary details for not displaying the details.
2. Every Petitioner must submit **proof of identity** (clearly with photo, name and address) to the Court for filing any case in any Court.
Kindly provide the details of Identity (consisting the Name as mentioned in the cases filed) produced by the petitioner for filing the cases mentioned in the above References.
3. Kindly provide the Name(s), Designation(s), Employee Identity numbers of the Magistrates and Superintendent(s) & PIO(s) worked / working (period of working) from 1st March, 2012 onwards to till date. If any of them are transferred, kindly provide place where they had transferred and present place of working, designation and employee identity numbers along with dates of transfer.
4. Kindly provide the rules of **jurisdiction of Court** to file a case u/s 498A of IPC. Also, kindly inform that whether any petitioner can file case U/s 498A of IPC in any Court without any jurisdiction limits. If so, kindly enclose the relevant Acts / sections and sub-sections.
5. Kindly provide the **documental evidences** produced by the petitioner (in Ref-1) and / or the SIP / Investigation Officer, O/o Police station – Yellareddy for filing the case (vide Ref-1) and Charge-Sheet in Junior Civil Judge Court – Yellareddy.
6. Kindly produce all the documental evidences (such as owning Property, Pay-Slip, evidences showing that respondent came to Yellareddy and

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 12-08-2017 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

The 1st Appellate Authority through Notice Roc No. 2273/SO-2/2017 dated 21-08-2017 informed the appellant that the First appeal is posted for hearing on 05-09-2017.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 17-09-2021 at 10.30 A.M.

The case was earlier heard on 26-10-2018 & 26-07-2019 and since the APIO did not file the copy of the Order communicated to the appellant on 28-07-2017 as such the case was adjourned.

The case is finally called on 17-09-2021. The appellant is absent. The PIO / Sri N. Venkat Reddy, Superintendent, O/o the Chief Ministerial Officer, Junior Civil Judge Court, Yellareddy, Kamareddy District and Sri J. Anil Kumar, Standing Council representing the First Appellate Authority / O/o the Registrar General, High Court of Judicature at Hyderabad, Hyderabad are present and has produced the copy of the Order communicated to the appellant on 28-07-2017.

Heard the PIO and perused the material papers available on record.

Since the factual information is furnished, the appeal is closed.
