Order

Sri K. Bhisma Gangeyudu, Hyderabad has filed 2nd appeal dated: 23-11-2017 which was received by this Commission on 25-11-2017 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 27-06-2017 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

As per my request the Hon'ble Public Information officer furnished my work review statements it was not included the incharge period disposals of Khammam, 1st Additional District Judge and Principal District Judge, Adilabad and 11th Additional Chief Judge, at City Civil Court, Hyderabad. *and other courts*

Hence I pray before the Hon'ble Public Information Officer to furnish the said incharge disposal which was not included in the earlier reference which is needful to submit to the Hon'ble Apex Courts.

The PIO vide Roc No. 533/PIO/JUDL/2017 dated. 31-08-2017 furnished the information to the appellant.

Aggrieved reply from the PIO, the appellant filed 1st appeal dated: 24-08-2017 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices are issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case was earlier heard on 06-12-2019 and finally on 03-09-2021. The appellant is absent. Sri Swaroop Oorilla, Standing Counsel and advocate on record for O/o the Registrar Judicial, High Court of Telangana, Hyderabad is present and submitted that a reply was given to the appellant vide letter ROC No: 533/PIO/JUDL/2017 dated: 31-08-2017. Aggrieved with the reply of the PIO the appellant filed 1st appeal dated: 24-08-2017 before the First Appellate Authority. The copies of order / decision passed by the First Appellate Authority are not filed before the Commission.

Perused the material papers available on record.

The Commission directs the PIO to give a specific reply and furnish the available information to the appellant within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
