Order

Sri K. Bhishma Gangeyudu, Hyderabad District has filed 2nd appeal dated: 23-11-2017 which was received by this Commission on 25-11-2017 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 02-08-2017 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

I have submitted an application Dt:28-05-2017 to the Central Government and Hon'ble Supreme Court to prosecute the Chief Judge City Civil Court, Hyderabad Smt P Sree Sudha and another. The Central Government forwarded my grievance to the Hon'ble Registrar General and PP's to the Hon'ble Chief Justice.

I have not received any action so far, I want to know the action taken by the Hon'ble Registrar General and Hon'ble PP's to the Hon'ble Chief Justice. Hence I pray before the Hon'ble authority to furnish me the action taken by the Hon'ble High Court and also request to furnish me the reply along with documents if any given by the Hon'ble Chief Judge and Administrative Officer to take further proceedings in this matter.

The PIO vide Roc No. 609/PIO/JUDL/2017 dated. 19-09-2017 furnished the information to the appellant.

Aggrieved reply from the PIO, the appellant filed 1st appeal dated: 24-08-2017 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices are issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case is called on 03-09-2021. The appellant is absent. Sri G. Naresh representing Sri A. Kranthi Kumar, Standing Counsel and advocate on record for O/o the Registrar Judicial, High Court of Telangana, Hyderabad is present and stated that a reply was given to the appellant vide letter ROC No: 609/PIO/Judl/2017 dated: 19-09-2017 subsequently on filing 1st appeal dated: 24-08-2017 an order was passed by the First Appellate Authority through appeal No: 144 of 2017.

On perusal of the material papers available on record, the Commission observed that instead of furnishing the action taken on the complaint dated: 28-05-2017, the PIO and First Appellate Authority have passed order only the 6(1) application dated: 02-08-2017 and the delay occurred.

The Commission directs the PIO to give a specific reply to the appellant with regard to the action taken on the complaint dated: 28-05-2017 filed by the appellant within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
