Order

Sri G. Narsing Rao, Hyderabad has filed a Complaint dated: 27-02-2020 which was received by this Commission on 27-02-2020 for not getting the information sought by him from the PIO / O/o the Deputy Municipal Commissioner, Circle No.8 GHMC, Charminar Zone, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 13-01-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

In reference to your reply to my Application under RTI dated 26-11-2019 3rd cited I have not received copies of notices served to Sri M. Babu Rao and other documents pursued by GHMC authorities, hence once again I urge and appeal to submit that I have lodged complaints vide reference 1st and 2nd cited against my neighbour Sri M. Babu Rao with regard to illegal construction without taking permission from GHMC, Hyderabad duly encroaching Govt. Land and affecting my easement right.

In my Application 3rd cited I requested under RTI Act, 2005 to furnish the details of action taken in the above matter.

Vide reference 4th cited PIO/Dy. Municipal Commissioner, GHMC stated that action has been taken by issuing Notices as per HMC Act 1955 and further stated that necessary action will be intimated as per rule. But not submitted any copies of the notices issued.

As such, I request you to furnish the following information under RTI Act, 2005.

And more few points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 13-08-2021 at 10.30 A.M.

The case is called on 13-08-2021. The appellant is present and stated that the PIO has furnished incomplete information. The PIO / Sri N. Giriraj, Assistant City Planner, O/o the Deputy Commissioner, Circle No: 8, GHMC, Charminar Zone, Hyderabad is present and submitted his affidavit stating that replies were given to the appellant vide letter No: 35/ACP/C8/CHRZ/GHMC/2019 dated: 03-01-2020 and vide letter No: 45/ACP/C8/CHRZ/GHMC/2020 dated: 17-06-2020 and filed the copies of the same along with the acknowledgement of the appellant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 13-01-2020 seeking certain information and the Commission is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
