Order

Sri CH. Bhanu Chander, Medak District has filed a Complaint dated: 24-02-2020 which was received by this Commission on 27-02-2020 for not getting the information sought by him from the PIO / O/o the District Rural Development Authority, (DRDA), Medak District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 11-11-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. ఉపాధి హామీ కింద నేను కనీసం పనిచేయడం అరగింకి F.A. గా పనిచేయడం అరగింకి నాకు ఏవేదమైన నోటాసులు పొందడానికి గ్రామ సభ తోటాడం తప్పక కంటే M.P.D. గారు 2010, 2014 హై కార్టర్ అనేకాలు పాటు తవ్వడం M.P.D. గారు స్పెక్టర్ నిర్ణయంతో నాకు పనులనుండి తలగించారు అప్పటి హై కార్టర్ అనేకాలు అమలు పొందుతుంటే చాలా పనులు నిబంధనల ప్రకారం అమలు పోతుంటే పాటునై జవాబులు ఇవ్వాలి.
2. అమలు 471. M.P.D. ప్రభుత్వ ఉత్తర్వులు 2010 సం. జనవరిలో హై కార్టర్ కంటే తాము అరగింకి కానికే సంబంధించిన నిర్ణయ పుస్తకం DRDA గారికి ఇవ్వమంటూ చాలా సార్లు విన్నాము కాని నాకు నాకు న్యాయం చేయమంటూ అసంపూర్ణ సమాచారం ఇవ్వడం ఉత్పన్నమే కాదు.
3. నాకు ఇప్పుడు ఇవ్వనింటే సమాచారం ఇవ్వాలి అనే విషయం నుండి సమాచారం సరిపెనది ఇస్తే ఉత్పన్నమే సమాచారం ప్రకారం కావాలి ఇవ్వాలి.

And more few points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 16-09-2021 at 10.30 A.M.

The case is called on 16-09-2021. The complainant is absent. The PIO / Sri P. Rajender Reddy, HR Manager, O/o the District Rural Development Authority, (DRDA), Medak District is present and filed his affidavit stating that the complainant filed numerous applications and the information was furnished accordingly and the same was again sent on 15-03-2021 to the complainant, but the PIO failed to submit the copy of the information furnished to the complainant before the Commission.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 11-11-2019 before the O/o the District Collector, Medak District seeking information on 6 points. The PIO / O/o the District Collector, Medak District vide letter No: B4/1709/2019 dated: 21-11-2019 forwarded the application U/s 6(3) of the RTI Act 2005 to the PIO / O/o the District Rural Development Authority, (DRDA), Medak District with a request to furnish the information to the complainant. Upon not filing the documentary evidence, the Commission cannot accept the submissions of the PIO.

The Commission directs the PIO to furnish the information once again duly attesting the same to the complainant immediately on the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
