Order

Sri K. Veera Goud, Sangareddy District has filed a Complaint dated: 02-03-2020 which was received by this Commission on 04-03-2020 for not getting the information sought by him from the PIO / O/o the Mandal Parishad Development Office, Sadasivpet Mandal, Sangareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 29-01-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. Job Chat of Mandal Parishad Development Officer.
2. Proceeding copies of grants released to total mandal gram panchayath's under 14 Finance Commission, State Finance Commission & G.P. General Funds etc., for the financial years August 2018 to till date.
3. Details / Proceedings of purchased tractors from total mandal gram panchayath's.
4. Birth and Death details of total gram panchayath's of mandal August 2018 to till date.
5. House permission details of all gram panchayath's in mandal August 2018 to till date.
6. Layouts details in all gram panchayath's in mandal.
7. Pension Beneficiaries details of all gram panchayth's in mandal to till date
8. All mandal gram panchath's residential particulars of Panchayath Secretaries under Section 43(8) of TS PR Act, 2018.

The PIO / O/o the Mandal Parishad Development Office, Sadavsivapet Mandal, Sangareddy District vide Lr. No. RTI/05/2020/MPDO/ dated. 31-01-2020 transferred the application U/s 6(3) of the RTI Act to O/o the Gram Panchayat Secretary, Kondapur Village & Mandal, Sangareddy District with a request to furnish the information to the Complainant.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 12-08-2021 at 10.30 A.M.

The case is called on 12-08-2021. The complainant is absent. The PIO / Smt. G. Andalamma, Mandal Prarishad Officer, Kondapur Village & Mandal, Sanga Reddy District is present and filed her affidavit stating that the information was furnished to the complainant vide letter No: A1/RTI/04/2020 dated: 31-01-2020 and again point wise information was furnished to the complainant vide letter No: MPO/05/RTI/2021 dated: 27-03-2021 and on receipt of the Commission notice dated: 22-07-2021 the same was once again furnished to the complainant on 10-08-2021. The PIO filed the copies of the information furnished along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 29-01-2020 seeking information on 8 points. The PIO further submitted that the complainant is seeking information about 24 Gram Panchayats and the same was furnished to the complainant.

The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
