Order

Sri Ashok Vemula, Pedapalli District has filed a Complaint dated 11-03-2019 which was received by this Commission on 12-03-2019 for not getting the information sought by him from the PIO / O/o the Senior Superintendent, O/o the Senior Civil Judge's Court, Pedapalli District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 25-01-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- 1) సీనియర్ సివిల్ జడ్జ్ కోర్టు పెద్దపల్లిలో ఉన్న OS No.-1/96లో ఏటీఎన్ కాపీ, జడ్జిమెంట్ మరియు డిగ్రీ కాపీ, లోక్ అదాలత్లో కాంప్లైజ్ అయిన ఆర్డర్ కాపీలను అన్నింటినీ సర్టిఫైడ్ చేసి ఇవ్వగలరు.
- 2) ఇట్టి కేసులో రిసివర్ (యం. మల్లేశం) గారు వేసిన రిపోర్టుల వాటి కాపీలను సర్టిఫైడ్ చేసి ఇవ్వగలరు.
- 3) గౌరవ కోర్టు వారు అడ్వైజరీ కమీషనర్ను నియమించిన ఆర్డర్ కాపీలను సర్టిఫైడ్ చేసి ఇవ్వగలరు.

The PIO vide Lr. No. Dis No. 282 dated. 13-02-2019 furnished the information to the Complainant.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case is called on 03-09-2021. The complainant is absent. The APIO / Sri V. Anjaiah, Senior Superintendent, O/o the Senior Civil Judge's Court, Peddapalli District is present and filed his affidavit stating that the information was furnished to the complainant vide letter No: Dis. No: 282 dated: 13-02-2019 and filed the copy of the information furnished along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 25-01-2019 seeking information on 3 points and the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
