Order

Sri Asghar Ali Khan, Hyderabad has filed a Complaint dated: Nil which was received by this Commission on 06-03-200 for not getting the information sought by him from the PIO / the Assistant City Planner, Circle No.9, Sardar Mahal, Charminar, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 30-09-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

ing information.

1) The Road-widening to Charminar to Falaknuma, done by Guli Qatab Shah Urban Development Authority and Municipal Corporation of Hyderabad in the Year 1986/87, wherein the main road of Shahali Banda Shops/Houses were demolished by G.Q.U.D.A & M.C. they acquired the land from H.E.H. The Nizam which area called, as Hawali Mangli Begum. area is opp. Asra Hospital, Adg. to Pista House Hotel. G.Q.U.D.A has given the letter No. 2292/P29/GQUDA/87 dt: 22-11-87. I need the copy of that letter and how much land by GQUDA from HEH The Nizam Trust. Complete Plan Charminar to Shahali Banda Road, pertaining to R. widening.

2) How many houses were there at Hawali Mangli Begum Shahali Banda, detail list, and how many were paying the G.H.M.C Tax, and the extent they occupy. The peoples who were not paying tax as per law. What action by G.H.M.C. will

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 13-08-2021 at 10.30 A.M.

The case is called on 13-08-2021. The complainant is present and stated that the PIO has not furnished the information. The PIO / Sri Abdul Faheem, Assistant City Planner, O/o the Deputy Commissioner, Circle No: 9, GHMC, Charminar Zone, Hyderabad is present and submitted his affidavit stating that the information sought is of more than 30 years, hence no records could be traced in their office.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 30-09-2019 seeking information on 2 points.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO / Sri Abdul Faheem, Assistant City Planner & the then PIO / Assistant City Planner, O/o the Deputy Commissioner, Circle No: 9, GHMC, Charminar Zone, Hyderabad for not responding to the complainant even after lapse of 34 months to the complainant. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to make a through search and give a specific reply to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
