Order

Sri. B. Ashok, Sangareddy District has filed 2nd appeal dated: 06-03-2020 which was received by this Commission on 06-03-2020 for not getting the information sought by him from the PIO / O/o the Executive Officer, Indresham Village, Patancheru Mandal, Sangareddy District and 1st Appellate Authority / O/o the Mandal Parishad Development Officer, Patancheru Mandal, Sangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 08-11-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. In August, 2019 The Grampanchayat Authority try to demolish (enclosed the paper cut copy) the newly constructing a RCC Building Cellar+G+3 at R.K. Nagar of Indresham ('Indresham to Patancheru road' beside petrol bunk) for unauthorised construction, but the building now constructing unauthorised floors, the G.P. authority or any authority given any construction permission to the said building after august 20th ?
2. If 'Yes' the answer of above question No.1, Provide me C.C. copies of the set of application(s) with attachments which the authority given permission(s).
3. If 'No' the answer of above question No.1, the authority taken which actions on the said issue please provide me day to day actions in table from 2019 August 21st to till dates.
4. The G.P.Authority taken, taking and will take actions on unauthorised constructions in Indresham village with colonies.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 30-12-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 12-08-2021 at 10.30 A.M.

The case is called on 12-08-2021. The appellant is present and submitted his affidavit that the PIO has furnished part information. The PIO / Sri T. Subash, Panchayat Secretary, Indresham Village, Patancheru Mandal, Sanga Reddy District and Sri. S. Raju, Mandal Parishad Officer, Patancheru Mandal, Sanga Reddy District are present and filed their affidavits stating that the information sought was furnished to the appellant vide letter No: GP/RTI/2019 dated: 15-05-2020 and filed the copy of the same along with the acknowledgement of the appellant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 08-11-2019 seeking information on 4 points and the PIO has not furnished the information for point No: 4. The PIO submitted that notices were issued for demolishing the illegal constructions.

The Commission directs the PIO to furnish the complete information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
