Order

Sri D. Vinay Kumar, Medak District has filed a Complaint dated 17-03-2020 which was received by this Commission on 17-03-2020 for not getting the information sought by him from the PIO / O/o the Mandal Parsihad Development Officer, Kangti Mandal, Sangareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 20-01-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- ⑤ గ్రామీణ శాసనసభలకు కేంద్రం నుండి వచ్చిన ప్రాజెక్టుల లిస్ట్.
- ⑥ గ్రామీణ శాసనసభలకు కేంద్రం నుండి వచ్చిన ప్రాజెక్టుల లిస్ట్.
- ⑦ గ్రామీణ శాసనసభలకు కేంద్రం నుండి వచ్చిన ప్రాజెక్టుల లిస్ట్.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 12-08-2021 at 10.30 A.M.

The case is called on 12-08-2021. The representative (Grand Father) of the complainant is present and stated that the PIO has not furnished the information. The PIO / Sri G.B. Venkata Narsimha Reddy, Superintendent, O/o the MPDO, Kangti Mandal, Sanga Reddy District is present and submitted his affidavit stating that a reply was given to the complainant vide letter No: A2/49/2020 dated: 04-02-2020 and filed the copy of the same before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 20-01-2020 seeking information on 7 points.

The Commission directs the PIO to give a specific point wise reply to the complainant and furnish the available information to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
