Order

Sri P. Srinivasulu, Nalgonda District has filed 2nd appeal dated: 17-03-2020 which was received by this Commission on 19-03-2020 for not getting the information sought by him from the PIO / O/o the Head Mistress, Government Girls High School, Sultan Bazar, Hyderabad and 1st Appellate Authority / O/o the Head Mistress, Government Girls High School, Sultan Bazar, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 31-10-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- ③ సంబంధిత కేంద్ర పాఠశాలల పాఠశాలల్లో అభివృద్ధి కను ప్రభుత్వ పాఠశాలల సమగ్ర అభివృద్ధి నికర దృక్పథం తెలుపగలను. అభివృద్ధి కను ప్రభుత్వ పాఠశాలల సమగ్ర అభివృద్ధి నికర దృక్పథం తెలుపగలను.
- ④ కృష్ణానది నది సంబంధిత పాఠశాలల అభివృద్ధి కను ప్రభుత్వ పాఠశాలల సమగ్ర అభివృద్ధి నికర దృక్పథం తెలుపగలను.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 23-12-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 26-08-2021 at 10.30 A.M.

The case is called on 26-08-2021. The appellant is present and stated that the PIO has furnished incomplete information. The PIO / Smt. Noor Jahan, Head Mistress, Government Girls High School, Sultan Bazar, Hyderabad is present and filed her affidavit stating that the available information was furnished to the appellant vide letter No: 94/GGHS/SB/RTI/2020 dated: 15-02-2020 and on receipt of the Commission notice dated: 29-07-2021 the same was once again sent to the appellant through speed post. The PIO filed a copy of the information along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 31-10-2019 seeking information on 4 points and the PIO vide letter dated: 14-02-2020 has furnished the available information.

The Commission directs the PIO to furnish the information for point No: 4 to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
