Order

Sri. B. Prabhakar Reddy, Hyderabad has filed 2nd appeal dated: 07-01-2020 which was received by this Commission on 10-01-2020 for not getting the information sought by him from the PIO / O/o the District Survey & Land Records Office, Wanaparthy District and 1st Appellate Authority / O/o the District Survey Officer, Cum Inspector of Survey, Wanaparthy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 12-06-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Survey copy with measurements of fish market in Sy. No. 366 & 367 at kothakota (Vill. & Mdl.) (Xerox copy with certified)
- 2) Notices issued to surround patta land owners (Xerox copy with certified)
- 3) Panchanama copy of the survey copy (Xerox certified)
- 4) Acceptance & Sign. copy of the neighbour land owners.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 04-08-2019 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 06-08-2021 at 10.30 A.M.

The case is called on 06-08-2021. The appellant is present and stated that the PIO has not furnished the information. Sri. G. Chiranjeevi, Deputy Surveyor is present on behalf of the PIO / Sri. J. Balakrishna, Inspector Of Survey & Land Records Office, Wanaparthy District filed his affidavit stating that a reply was given to the appellant vide letter Rc. No: RTI/03/2019 dated: 29-06-2019 and filed a copy of the information furnished along with the acknowledgement of the complainant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 12-06-2019 seeking information on 4 points and the PIO vide letter dated: 29-06-2019 replied that for Point No: 1 the information was furnished and for point No: 2, 3 & 4 the information is not available in the file. The Commission cannot accept the submission of the PIO.

The Commission directs the PIO to furnish the balance information for point No: 2, 3 & 4 to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
